What Memories Are Made Of

Shirley Meeks has a zest for life that has brought her soaring through the skies and dancing across a world-famous stage, making celebrity friends along the way.

The Salisbury native, now 86, dreamed of becoming a dancer as early as age two. That's not much of a surprise, considering both of her parents danced and her dad taught dance during her childhood years. Shirley did what many young ladies dream of doing; as a teenager she earned a coveted slot with the Rockettes, the legendary chorus line that has performed for more than 75 years at Radio City Music Hall.

The Rockette shows were, and still are, lavish and spectacular. Their productions accompanied movie releases, like *Casablanca* and *Yankee Doodle Dandy*. Their costumes, designed by greats such as Vincent Minnelli added glamor to the amazing precision quality of the line. Perhaps their best-known routine is an eye-high kick line performed in perfect unison at the end of every show.

She worked at Radio City Music Hall as a Rockette in the 1940s — drawn to New York City, like so many youth, by the

lights and glamour. During the World War II era the Music Hall played host to major stars of the day, including Judy Garland. Shirley also toured with the Roxettes, the forerunner of the Rockettes.

Shirley achieved another dream by becoming a pilot in the 1950s, and later opened her own dance school, the Shirley Meeks Dance Academy. There she instructed former Wicomico High students who would go on to become quite famous: Actress Linda Hamilton, of *Terminator* fame, and John Glover, who is best known for his villainous role on TV's *Smallville*. In 2011 Glover participated in the Alzheimer's Association Walk to End Alzheimer's™ in honor of Shirley and in memory of his late father.

Though she has achieved big things in life, today, with the help of Coastal Hospice, Shirley continues to enjoy the simple things—a delicious meal, relaxing outside and watching nature with her longtime friends. She also enjoys visits from a Coastal Hospice music therapist and spending time with her son and three grandchildren.

We are honored to count Shirley as one of our patients. She truly is a star!

Message from Alane Capen, President of Coastal Hospice

The year 2011 has been a year of dramatic growth. The number of patients in our care on any given day jumped from 108 at the start of July 2010 to more than 155 at the end of June 2011.

To accommodate the increase in patients, we added a third care team to ensure that every patients' needs were met. We've also increased our medical staff adding two part-time physicians assigned primarily to Coastal Hospice at the Lake.

The Coastal Hospice Thrift Shop, opened in April, 2011, has made new friends for us in the community and will generate the revenue needed to operate Coastal Hospice at the Ocean and provide for patients who cannot afford to pay us.

We've also increased other outreach efforts to help the community better understand hospice care and what we have to offer. That way, those facing life-limiting conditions who would benefit from our services are more likely to call us.

Perhaps most important, we have kept our promise to put our patients' needs first. The community has come to rely on Coastal Hospice & Palliative Care. And we rely on our donors. Thank you for your investment in our mission.



Ask Dr. Dave...

Q. My mother has breast cancer that has spread to her liver. When her Oncologist started to talk to her about the test results, she stated that if it was bad news, she did not want to know. She is mentally normal. Her doctor spoke to me privately and stated that she had a good chance for a palliative response to chemotherapy, but he could not proceed without informed consent. What should I do?

A. It is important that your mother's wishes be respected. Although most patients do want to know the facts, some do not. Her doctor is also correct that he cannot provide treatment without informed consent. The next step is to ask your mother whom she wants the doctor to tell about the test results and make medical decisions for her. Perhaps a medical power of attorney form has already been completed defining who her decision maker will be. Hopefully her medical care can proceed appropriately once

this step has been completed. It is likely that your mother does know that her cancer has recurred, at least at some level. At some point she may ask questions about her diagnosis and should that happen, I would certainly answer them in an honest and straightforward manner. The question can also be re-framed by asking her what she thinks is going on with her health. Most cancer centers have counseling staffs and/or palliative teams that can provide further support for her and for your family as well. Ask for their help.

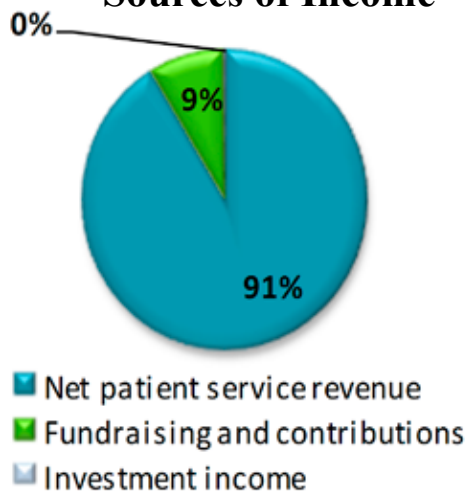

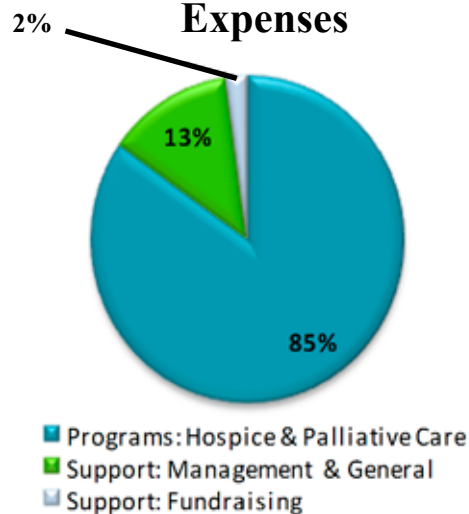

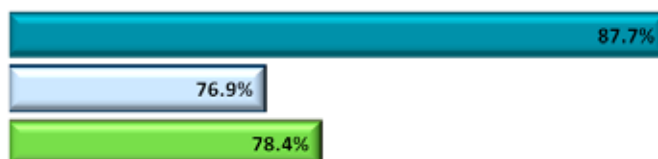
